Annual General Meeting Minutes

June 23rd, 2019

The annual general congregational meeting of Lakeview United Church was held at the Church on Sunday, June 23, 2019, following morning worship.

1. <u>CALL TO ORDER</u>

Daryl Sedor called the meeting to order at 11:20 am.

2. OPENING PRAYER AND MINUTE OF SILENCE

An Opening Prayer mindful of our ministry of service within and beyond our church was offered by Interim Minister, Kelley Warner. A minute of silence in Memoriam was offered for William Bell, Dorothy Borwick, Dave McCrae, Thelma Moules, Mary Joan Muir, Karen Anne Bayerle and Audrey Eloise Reid-Bicknell who died in this past year.

3. This meeting was called in accordance with Sec. B.5.2, The Manual 2019, The United Church of Canada.

4. MOTION FOR APPOINTMENT OF CHAIR AND SECRETARY

Motion to appoint Hank Klassen chair and Carolyn Bosch as secretary for this AGM was made by Ron Gillean and seconded by Paige Martin. CARRIED.

5. <u>QUORUM</u>

Hank Klassen stated that quorum was reached and declared this an official meeting of Lakeview United Church.

6. VOTING PRIVELEDGES and MANNER OF VOTE

Hank Klassen explained that voting will be by show of hands. Motion that members of the congregation grant voting privileges to adherents at this meeting was made by Judy Klassen and seconded by Gwen Jamieson. CARRIED.

7. <u>APPROVAL OF AGENDA</u>

Hank Klassen requested that New Business be moved from item 15 to item 13 on the agenda. The amended agenda was approved by a show of hands.

8. MOTION FOR APPROVAL OF AGM MINUTES OF MAY 27, 2018

Motion to approve the Annual General Meeting minutes of May 27, 2018 was made by Ron Gillean and seconded by Paige Martin. Daryl Sedor requested that the spelling for Lesley Sedor be corrected (from Leslie) in item 9. Slate of Council Members. Hank Klassen asked for a vote on the motion with correction as noted. CARRIED.

9. MOTION FOR APPROVAL OF AFM MINUTES OF MARCH 3, 2019

Motion to approve the Annual Financial Meeting minutes of March 3, 2019 was made by Don Rigby and seconded by Roger Scroggins. CARRIED.

10. ACCEPT ANNUAL REPORT AS SUBMITTED

Motion to receive for information the annual report for 2018/19 was made by Daryl Sedor and seconded by Jeannie Butterworth. CARRIED.

11. MOTION TO ELECT MEMBERS TO LUC COUNCIL

Motion to elect the Carolyn Bosch as Secretary, Paige Martin as Treasurer, Lesley Sedor as Chair of Reaching Out Committee, Beckie Scroggins as Chair of Ministry and Personnel, Daryl Sedor as Chair of Affirming Ministry and Daryl Sedor as corepresentative of Chinook Winds Regional Representative was made by Daryl Sedor and seconded by Fiona Hayes. CARRIED.

The following positions remain unfilled. Council Chair, Finance and Facilities Committee Chair, Faith Formation and Worship Chair, Fellowship and Caring Chair, Chinook Winds Region Co-representative. Daryl Sedor urged people in the congregation to step forward to fill the empty positions. He requested that people who haven't contributed lately consider offering their time and commitment.

12. <u>APPOINTMENT OF ADDITIONAL MEMBERS TO COUNCIL</u>

Motion to allow LUC Council to appoint additional members as needed to fill open positions was made by Beckie Scroggins and seconded by Fiona Hayes. CARRIED.

13. <u>NEW BUSINESS</u>

Daryl Sedor explained that people have asked members of Council to consider allowing beer and wine to be served at functions. Historically LUC has been a dry space, but upon investigation, the only references found to determine this church being an alcohol free facility is stated within our agreements with renters. Nothing is stated in our bylaws to this effect.

Motion to allow user groups (member and rental) to serve beer and/or wine at functions within the church premises when a liquor license has been properly secured was made by Daryl Sedor and seconded by Paige Martin.

A number of questions and concerns were expressed with resulting dialogue:

- Consideration for Alcoholics Anonymous who are renters of space
- How does United Church of Canada feel about allowing alcohol on the premises? There is nothing available to suggest that it's not allowed and other United Churches in the city allow wine and beer consumption as well as other faith communities.
- A vote to allow alcohol consumption at LUC was held in the past, but it is thought that it was focused on serving wine at communion. This vote was narrowly defeated.
- How will it be decided if a renter is allowed or not allowed to serve alcohol?
- If someone leaves the church, after having consumed alcohol, and has an accident who is responsible? Whomever secures the liquor license is responsible.
- If people become inebriated and there are negative consequences how will we feel as a church?
- May require a policy about when renters can acquire a license and who is responsible to make sure the church is left in good condition. LUC has personnel and wisdom necessary to control potential misuse. Trustees have placed rules in rental agreements that require rental space be left in good condition.
- Wine can be a celebratory, cultural tradition such as a toast given at a wedding.
- No hard liquor.
- Could try a pilot to see the response.
- Liquor must be consumed indoors. Liquor license requires indoor consumption.
- Who? Renters and members. LUC's policy is to rent to non-profits. The intent is **not** to rent space to different user groups by introducing the

ability to consume beer and wine, but to allow current renters and users to occasionally serve alcohol at a function.

- It would be nice to serve beer and wine at intermission at an evening concert or during a funeral reception in the upper hall.

Hank Klassen asked for a show of hands. 23 in favour, 6 opposed, 2 abstained. CARRIED.

No other new business was presented.

14. <u>RECOGNITION OF FAITHFUL SERVICE</u>

Paige Martin and Hank Klassen requested that the following members who have completed their terms on Council come forward for recognition. Gwen Jamison and Louise Poudrette - Faith Formation and Worship Sue Spratt - Fellowship and Caring Committee Fiona Hayes – Ministry and Personnel Daryl Sedor – Council Chair A token of appreciation in the form of a white rose was presented.

Paige Martin asked the congregation to consider the decades worth of time and talent that have now stepped away from Council. She urged people to consider stepping forward to fill vacancies.

15. THANK YOU TO OUR STAFF, COUNCIL AND COMMITTEE MEMBERS

On behalf of the congregation Hank Klassen thanked staff, council and committee members for their time and commitment given to the church. Accepted with applause.

16. <u>BLESSING</u>

Interim Minister, Kelley Warner provided a closing prayer.

17. ADJOURNMENT

Hank Klassen declared the meeting adjourned at 11:58 am

Lakeview Council Report (the year at a glance in no particular order)

There is an expression that is said to have come from an ancient Chinese Curse, which says, "May you live in interesting times." Depending on your circumstance, you may consider this to be a curse or a blessing.

The Lakeview United Church congregational year 2019-2020 can certainly be described as "interesting times".

The previous church year ended with the resignation of our chair of council, Daryl Sedor, as he had completed his term of office on June 30, 2019. Daryl remained on council as our representative to the UCC Chinook Winds Regional Council. Daryl has been and remains a valuable member of Council and a mentor to his fellow council members. His wisdom and experience have helped us through many discussions on critical issues around the council table.

The new church year began on July 1, 2019 with 3 unfilled positions: Council Chair, and committee reps for Finance & Facilities and Faith Formation & Worship.

Council continued to function, even with the empty seats. Members took turns chairing the meetings while work was going on behind the scenes scouting for

potential members to join the council. In January of 2020 Kurt Perkins joined as Chair of Finance & Facilities and I, Bob Gibennus, joined as Chair of Council.

I spent the first two months of my term getting familiar with the role and suddenly in mid-March COVID-19 hit. What to do? Council held a virtual meeting online to discuss what might be our response to this new situation. From



this meeting and multiple emails back and forth came the decision to suspend public worship after March 15.

We arranged to hold virtual council meetings using Zoom. Our minister, Rev. Jope, stepped up and created worship services that can be accessed on our computers at home while we all remain in isolation. Rev. Jope continued to minister to us all by reaching out by telephone and being available when we needed him. Many of you ministered to each other in this way as well. The Spirit is definitely at work!

As we approach the beginning of a new church year, four members of council are resigning.

1. We thank **Paige Martin** for serving as our **Treasurer** over the past four years and wish her all the best as she takes a well-earned break from this most important role.

I am thrilled to announce that **Robbie Temple** has agreed to let her name stand for the position of Treasurer for the upcoming term. Robbie has been a member at LUC since 2007 and is certified as a CMA...and has a whole career in personal and corporate taxes and accounting. We look forward to her faithful participation on Council.

- 2. We thank **Carolyn Bosch** for her hard work and faithful dedication as the **Council Secretary** this past two years and her many years as Treasurer before that. We wish her well as she transitions to her new life in Canmore.
- 3. Lesley Sedor, having completed 3 years on Council as the chair of the Reaching Out Committee, is ready to step aside to make room for someone else to offer their gifts to this important ministry. Thank you, Lesley, for your love and dedication to our community of faith.
- 4. **Kurt Perkins** has made the decision to step aside from the role of Chair of Finance & Facilities. We thank Kurt for his participation on council this year.

LOOKING FORWARD

The remaining members of Council: Bob Gibennus (Chair), Daryl Sedor (Affirming Ministry and Chinook Winds Region Rep), Beckie Scroggins (M & P), Lorna Flack (Fellowship, Caring & Welcoming), and Janet Layton (Rejuvenation Task Force) will continue to work hard on your behalf. Council's first project this year will be to modify our Governance model to better reflect our current needs.

We continue to pray that the Spirit will lead us do our part in helping Lakeview United to be the church that God wants us to be.

Finance & Facilities Committee Report

Finance

The Finance Committee is a Sub-Committee of the Facilities & Finance Committee that reports to the Church Council. The Treasurer and other members of this committee work with the Council to compile the annual budget, and track spending.

For at least the last four years (at least), there has been no chair of the Facilities & Finance Committee, until Kurt Perkins thankfully took this on from Dec 2019 to June 2020. With this position vacant again, it is once again of concern that there is no other level of formal financial oversight, and that the workload of this position often falls onto the Treasurer position.

The Treasurer (Paige Martin) presented the 2019 Annual Financial Report and 2020 Budget to Lakeview United Church members and adherents on March 1, 2020. At that time the forecast deficit for 2020 was \$24,700.

Since that time, the COVID-19 pandemic in March 2020 has forced the closure of most of our rentals, and Sunday services with a subsequent loss of revenue and contributions. The Church has applied for and received the Canada Emergency Wage Subsidy for our salaried staff and the Concert Series has generously donated \$5000 to local operations. This along with accessing past savings should allow us to survive this extraordinary year. However as we have been running deficit budgets for several years, the reduction in our savings to fund those deficits, will have implications in the longer term.

The Investment Committee (Don Linton, Hank Klassen), is a sub-set of the Board of Trustees. They continued to monitor the investments in GIC's and the Canoe Capital Fund (formerly Fiera).

Pledgefest this year was managed by Heather Mayers and Heather Dorin.

Ted Prince, Counter Coordinator, ensures that Sunday morning volunteers are available to count each weeks' givings and make deposits to the bank. He is always seeking additional volunteers.

Shelly Logan-Gordanier continues in the role of ADP Payroll Coordinator. She coordinated payment of our full time employees in compliance with the United Church of Canada, the provincial and federal government requirements.

Nancy Gillean, Office Liaison, continues to help our Office Administrator Arda Kristanto.

Many thanks to the above-mentioned volunteers (and staff) for filling and fulfilling these roles that keep Lakeview United Church in good and sound financial standing.

This is my fourth year as Treasurer and I will be stepping down at the end of June 2020. Robbie Temple has agreed to stand for election as Treasurer going forward.

There are more than a few other vacancies and some of these dedicated volunteers have served well beyond the expected length of a two year term. Please consider stepping up to fill any of the above-mentioned positions which are vital to ongoing financial viability of our church. Submitted by Paige Martin, Treasurer 2020

Property

The Facility committee has the primary responsibility in managing and reporting to council on:

• property management, rentals, repairs and improvements Please see the separate report on the rentals and management prepared by Roger Scroggins.

The property management saw a few repair and replacement projects this fiscal year:

Various pieces of sound and AV equipment were replaced or added to replace equipment that reached the end of its useful life.

Paving repairs were carried out in summer of 2019, and new stall lines painted, which should extend the life of the paving by a few more years.

Upgrades from fluorescent to LED Lighting in the lower floor Sunday School rooms (in the 1995 addition area) were completed in early 2020. This will results in a lower power use and longer life for this area of the lighting. Most interior lighting has now been upgraded to LED upon the completion of this project.

Solutions for the annual water infiltration issues have been researched and costed but due to the high cost no action has yet been taken. With revenue decreasing due to the COVID-19 pandemic, large expenditures have been put on hold.

The janitorial and exterior maintenance services continued to be provided under a 3 year service contract with Calgary Services Ltd. A reduced service was negotiated with the contractor due to the reduced use of the facility during COVID-19 shutdown.

Rentals

Rentals at Lakeview United Church were quite active until we reached mid March when virtually all activities halted. The only existing group to continue meeting from mid March to June 1 was AA on Friday night.

Calgary Girls Choir was fully expected to join us starting in May, but decided in February to remain at St. Mathews United.

Al Madinah started a three month trial on April 17 for Friday Prayers (1:00 - 2:30pm). They also spent the Ramadan month at Lakeview for late night prayers. Everything has gone well with them although their attendance to date has been low. We anticipate that they will want to continue at Lakeview for the future.

Pedal Heads are still expected to do bicycle training starting in late June.

Foothills Concert Band has contacted us through member Pat Warren and may join us starting in September on Monday evenings from 7:00 – 9:00 PM.

On May 21 and 22, we had significant flooding in the East Lower Hallway and rooms 4, 6 and 8 on the north side of hallway. Also the lower hall flooded in the North, West and Southwest areas. Had Student care (before and after school) been active during this time it would have been an issue to continue their normal activities.

Rental inquiries recently have increased as we enter the month of June.

Minister's Report

2019-2020 has been a wonderful journey together and I again am so humbled by all of the hopes and the dreams, the prayers and actions, and the love and the compassion that has so freely come from the hearts of each and every one of you. As we all journey through this COVID-19 pandemic what happened months and months ago may not be on people's minds but it is of grave importance in that it does show that there is hope amongst the strife and that one day, we may realize some sort of normality. As I've entered now into the seventh year of my ministry with all of you, it might be helpful to share some of the highlights of what has transpired and of what important parts frame our spiritual journeys. Before this virus took over, we were seeing a good number of folks attending Sunday worship and we were all being fed well, both spiritually and of course the gatherings following worship where the plates were filled. And speaking of plates, our financial situation was in fairly good shape but at this juncture, only time will tell. Our building is in good shape and a huge thank-you goes out to all of those who help make it so. It is through believing in 'self' and believing in doing things together where 'church' becomes more than just a word – it becomes a community of 'selves' where God's kingdom becomes realized...hats off to all of you for your stick-to-itiveness and your belief in each other! So let's take a brief look at what has happened in my life as your minister in the 2019-2020 period:

a) Worship –this has been and always will be an integral part of the church's function and many folks have put this as one of their highlights of their week. I can see this also today by the numbers who are joining in with the Sunday virtual services and for those who have been tapping in to my daily blogs. Over the year, we have been truly invitational and hospitable to visitors and also to those who have been members or adherents for many years. We have introduced 'new folk' and we believe they like what they see. We will need to keep this momentum going as the possibility of members of St. Matthew's come and worship with us. Once again, my thank-you and countless kudos to the greeters, to the readers, to those who light candles and share in communion, to the technological gurus, thanks to the choir and to Marie and to the various accompanists, to the ones who labour in the kitchen, who change light bulbs, who organize everything from Council matters to mopping basements, to Arda for her relentless work of keeping the office matters together, to rental and the such, and so on – you are truly blessed and the word 'thank-you' could never show the appreciation which all of us offer to you. You know who you are so stand up and take a bow...yeah, right now!

- b) Book Studies, Bible Studies, Warming Up to Worship I'm always amazed how these studies develop – they are organic and meaningful and wellattended. There is so much to glean from the biblical texts and how they speak to us and how timeless the messages are for all of us. Thank-you to those who facilitate them and give of their time and energy – and love.
- c) Special Services And I will mention a few of them whereas some of the special services needed to be cancelled due to the pandemic. Epiphany, Pentecost, Remembrance Day, Advent, The Longest Night, Christmas Eve, Staywell, Garrison Woods, Garrison Green and many funerals and weddings and baptisms these all brought the Message or the Gospel closer to many, many folk and we need to acknowledge that our ministry reaches places where sometimes we forget the people which it touches or it changes. Easter was different but memories of last year still linger and hope for next year brings on a feeling of optimism.
- d) Church Suppers (such as Shrove Tuesday) and snacks and beverages following worship, well-stocked and well-managed library, office staff par excellence, refugee family committee and all the help involved with this, monies shared with social agencies in the city, food bank donations and

emergency help to those in need, and we could list so many more initiatives and so thankful that we have opportunities of being the hands and hearts of Christ.

- e) A thank-you to those who gave their energy towards Pledgefest, hat's off to those many folk who make the concert series work, a salute to everyone who came to Entheos to listen to Brian Pearson and David Swann, a deep thank-you to all of you who pitched in while I was on sabbatical, a virtual hug to all of those who worked diligently on Council, our Trustees, the various committees, and if I've missed anyone, my apologies and you know who you are.
- f) Al Madinah This has only been a short exercise so far and with the pandemic, their numbers have been quite low but I sense that what we are offering to them is of great importance to collaboration, to learning of other religions and cultures, and ultimately, listening to what God is asking us to do.
- g) And where we are now as Bob Dylan sang: "The times, they are a changing" Yes, they truly are and I would be remiss in not speaking a little to this. In the 2019-2020 period, this pandemic has taken away a quarter of this church year and may linger a lot longer than this. I thank, deeply, those who have been communicating on a regular basis to church members and adherents alike. This shows the faith we have and the caring that comes with this. We shall overcome and this needs to be our mantra.

I realize that this may be a small picture of who we are and what we have accomplished (or what I may have done) but I truly encourage you to look back at these deeds and to offer a large thank-you to those who so diligently kept your church and your community alive.

In conclusion, I once again offer my thanks for the many years of believing in me and allowing me to believe in you and to also share in your faith journey. 2019-2020 was a good year and there will be nothing more than better years to follow and excitement will fill your hearts and fill the pews. Peace and blessings to all of you and may this upcoming year be one of wonder and one of newness. May the God of the ages touch your hearts and the Spirit of Christ live within you.

Faith Formation & Worship Report

Greetings everyone from your Faith Formation & Worship Committee. Monday Morning Bible Study

The Monday Morning Bible Study Group is a small group of women which meets in the upper hall twice a month on (surprise!) Monday mornings. We love the challenge of looking at scripture in new ways. In 2018/2019 we studied the Gospel of Thomas, which is a collection of things that Jesus supposedly said. We completed it in the spring of 2019. We don't regret taking this on, but we were glad that these writings didn't make it into the Bible.

In the fall of 2019 we did a 5-session study of "Birth of Jesus for Progressive Christians" by Donald Schmidt, a United Church minister in Penticton, B.C. We felt it was an excellent way to prepare for the Advent and Christmas season. The author gave us new concepts to think about.

Items collected for our Lenten project have yet to be delivered to Inn From the Cold once their doors open again due to Covid 19 pandemic. Thank you for all your support.

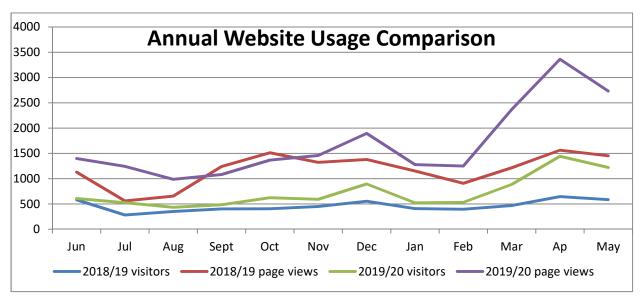


We had to forgo our much loved Annual Garage Sale due to the Covid 19 pandemic crisis. We know that many of you would have given to this situation as you are able.

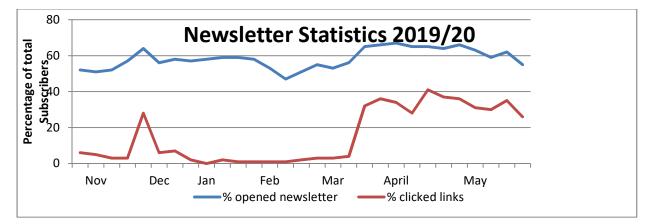
Website Analytics Comparison 2018/19 – 2019/20

Website utilization has substantially increased after the launch of the new version in 2017. In the period June 2018 to May 2019, a monthly average of 461 visitors and 1,174 page views were recorded. In the subsequent period, June 2019 to May 2020 the number of visitors to the website increased by 59%, to a monthly average of 731 and page views increased to an average of 1,702 per month. The number of page views per visitor stays relatively the same in the compared time periods at 2.5 page views per visit. But these are unusual times. As illustrated in the accompanying graph, a spike in website traffic coincides with the Covid-19 pandemic lockdown starting in mid-March 2020. Compared to results in March, April and May of 2019, the website experienced a 109% increase in visitors and a 100% increase in page views. Hits on "Rev. Jope's Blog", "Message from the Pulpit", "Bulletin Announcements", and "News" website pages drove these increased numbers. If we eliminate the 'lockdown numbers', there would still be a healthy increase of 36% in visits, and a 21% increase in page views in 2019/20. Website pages accessed by visitors continue to trend away from utilitarian rental inquiries, Church contact information, and Personnel searches, though visits to these pages are still increasing overall with the 'rising tide' of increased visitors. It is interesting to note that that our church family and beyond are now linking directly to the specific pages they frequent, such as the popular website pages noted above.



We continue to communicate with 211 subscribers by way of the e-mailed weekly Newsletters. An average of 58% of these newsletters are opened by the recipients. Fifteen percent of the conveniently embedded links (primarily to specific website data) are clicked. As with the website spike coinciding with the 'lockdown', the number of clicked links has substantially increased in this time period, while the number of Newsletter openings slightly increased. This is illustrated in the graph provided. The Thursday mail-out demonstrably drives traffic to the website. As we have been told, our subscribers appreciate being kept up to date on Church affairs, especially during the current pandemic. If you wish to be included on the mail-out list, please forward your email address to the Church Office.

I would like to take this opportunity to thank Arda for her hard work and continued collaboration as we endeavor to connect with you all. As always, feel free to contact the webmaster directly for further information, or to express concerns.

Affirming Ministry Report

Rejuvenation Task Force Report

The Rejuvenation Task Force has had an active year. In fall of last year, the RTF began the process of hiring for a Congregational Enhancement Coordinator. In order to clearly define the objectives of the position, it was decided to delay the process and consult with Edge for guidance. This was accomplished on February 6, 2020 with a conference call to Carla Leon from Edge in Ontario. The possibility of purchasing services from Edge for a six-month period is under consideration.

On the advice of Edge, a meeting was held on February 19, 2020 with Rev. Jope, Bob Gibennus as Council chair, and the RTF. The focus of the meeting was to explore the goals of the LUC and the role the RTF can play in achieving these goals. After a very successful meeting it was decided to continue meeting in the future.

Then the virus hit. Since the cessation of service and closure of the church, the RTF has been challenged as to how to continue this valuable work. Contact has been maintained and work will continue on line.

In the absence of the M & P at that time, the RTF initiated an application for a Canada Student Grant. This application has been accepted. However, due to the corona virus, an application has been made to modify our original proposal to move the dates later into the summer and fall.

I must acknowledge the amazing work of the members of the RTF committee, Cecilia Pavao, Jocelyn Barton, Craig Cheffins, Wayne Gordanier, Bill Penhale, and Daryl Bernie. Their support and undeterred commitment to the rejuvenation of LUC is an inspiration and clearly demonstrates their belief in the power of God.

Board of Trustees Report

The Board of Trustees is mandated by the United Church of Canada to hold in trust the building and property. To this end the Board insures the building is adequately insured, well maintained, rental agreements are such as to protect the property and that any investments are sound.

The insurance coverage for the building remains at \$2,884,248. The trustees reviewed our insurance and received a quote from HUB International (who is group insurer for the United Church of Canada). For 2020 the premiums are \$4714.00, an increase of \$104.00. Maintenance of the church is being kept up according to the Church Council plans. Likewise the rental terms of reference established several years ago are working well.

In 2016 the Lakeview Church Council reviewed and changed the church's investment policy. In May of 2016 \$312,000 of the church's bequests was invested with Fiera Capital Fund. This fund is the investment choice of the United Church of Canada. The earnings on this fund are doing well and some GIC money was moved to this fund on their maturity in May of 2017. The fund continues to perform well.

Thank you to George Zvanchuk, Paige Martin, Nancy Gillian, Don Linton, Diane Johnstone, and Elizabeth Marshall. Thank you also Rev. Jope Langejans for his advice.

Appendix 1: 2019 Annual Financial Report

The Treasurer is pleased to submit reports and financial statements concerning the financial affairs of our Church for 2019. Attachments include the 2019 Balance Sheet/ Income and Expense Statements.

Briefly stated our financial responsibilities relate to the following:

- LUC annual operating budget (Fund 01) which covers staff salaries, administration costs, maintenance of the LUC property, as well as the ministry of various other committees and programs, and the assessment by the United Church of Canada.
- Mission and Service (Fund 02) is a United Church of Canada program which allocates funds to Canadian and international programs that share our mission.
- Reaching Out (Fund 03) is a program that provides a helping hand to local charitable organizations and LUC sponsored programs.
- Other funds for specific projects/needs.

We depend upon the following sources of revenue to meet our financial commitments:

- Annual pledges
- Unpledged donations and weekly plate donations
- Rental of our Church facilities
- Proceeds from investments (GIC/Canoe Share Fund)
- Miscellaneous income

It is important to note that money donated to *Reaching Out* and *Mission and Service* flows directly into those programs.

The following is a brief summary of the financial picture for Lakeview United Church for the year just ended. I have rounded dollar figures to the nearest hundred dollars in the text for ease of reading. Exact figures can be found in the attached financial statements.

End of Year Finances - 2019

Consolidated Balance Sheet (page 6)

This balance sheet shows all assets, liabilities and equity for all funds.

Our cash position is up from a year ago as we cashed in GIC's with our former bank (Scotia Bank) in transferring to our new bank First Calgary. We continue to hold GIC's and our investment in Canoe Financial (formerly Canoe Capital).

Our value in total assets increased by \$105,000 primarily due to exceptional earnings in our Canoe Financial investment as well as higher than average pre-paid pledges, made in 2019 for 2020.

Fund 01 General Fund – Income and Expense Statement (pages 7-9)

A look at the Fund 01 Income and Expense Statement for 2019 shows that we ended the year with a deficit of \$28,200 (before transfers) compared to a projected a deficit of \$30,600 (before transfers) at the beginning of the year.

Income - \$8,300 below budget

- Actual Pledged amounts received were low by \$7,000
- Net gain on investment higher by \$9,200
- This was offset by lost rental income from Possabilities who defaulted on their last months payments and terminated their lease mid-year total rental income was \$13,500 below budget.

Expenses - \$10,800 below budget

- Salaries and salary expenses were much below budget as we did not pay for a pastoral care position during sabbatical, saving ~ \$8,400.
- Church property over budget (\$3.9k) due to high electricity costs in Feb and pergola removal costs, furnace repairs and tree service.
- In almost all other areas, spending was below budget.

Transfers into Fund 01 (for accounting reasons, these are not treated as income).

- The Concert Series Fund (10) donated \$578 to Fund 01 in aid of their share of assessment costs.
- The summer student is primarily engaged to foster community engagement. The funding for this position came from Alberta STEP grant (\$3,400) and the remaining costs (\$4,700) was transferred from Planned Giving Fund (15).
- The cost of Pulpit Supply (\$4,400) during Rev. Jope's sabbatical was transferred from the Sabbatical Fund (23).
- At the discretion of the Board of Trustees, \$18,400 was taken from the investment profits of the Planned Giving Fund (15) to eliminate the deficit in Fund 01.

After these transfers are taken into account, the net deficit for the General Fund is 0.

Accounting Fund Balances (page 10)

The accounting fund balance sheet shows the allocation of our cash and investments into differing funds. Most of our activity flows in or out of Fund 1, which is used for general operations, and has been discussed above. We use all the other funds to track spending on other specific

activities. In addition, some portions of the balance of some funds may be invested in GIC/Canoe Financial Funds, the income (or loss) from which will go to that fund.

Fund 1 General Fund. The balance of Fund 01 looks very large, but this includes the value of our church building, land and equipment (\$1,161,480 of fixed assets). The remaining \$105,500 is in cash, GIC and Canoe shares.

Fund 2 Mission & Service. Income to this fund is received each week according to your contributions. This is tallied each month and sent to the United Church head office for our contributions to M & S.

Fund 3 Reaching Out. This is also funded by your weekly contributions. The Reaching Out Committee, headed by Lesley Sedor, meets periodically to determine how these funds should be distributed.

Fund 4 Rejuvenation. This is for minor ongoing costs for projects/events initiated by the Rejuvenation Task Force, including the Bob Ross Paint Night.

Fund 5 Affirming Ministry. This is for ongoing activities associated with being an Affirming Church (as of 2019), under the leadership of Darryl Sedor.

Fund 7 Maintenance Reserve. This is to fund building lifecycle upgrades. This year the Property Committee undertook upgrading the pavement in the parking lot.

Fund 10 Concert Series. This program continues to do well income from concerts exceeding costs.

Fund 15 Planned Giving – This fund is very large due to two generous bequests in previous years. The monies in this fund have been invested in GIC/Canoe Shares, gains from which totaled \$61, 900.

Money from the Fund is to be distributed according to our Planned Giving guidelines that include the three guiding premises of "Reaching in"- work in the church, "Reaching Out" – work beyond our congregation and "Reaching Up" – education and training to further Christian learning.

Fund 18 Projects. The income in this fund was from yet another successful garage sale, headed up by Janet Layton, which was put towards the parking lot improvements (Fund 7). There were also GIC/Canoe earnings.

Fund 21 Refugee Fund. Our refugee family is now pretty much self-sufficient. The Refugee committee voted to donate \$5000 from this fund to help a private sponsorship of a refugee family from Kenya.

Fund 23 Sabbatical. This fund is set up to fund the replacement minister costs while our minister is on sabbatical. This year Rev Jope took his sabbatical. Kelly Warner and Bob

Gibbenus filled in at the Pulpit and Rev Jope arranged a Pastoral Care coverage swap with Reb Crowdis. The cost of Pulpit Supply (\$4400) was transferred to Fund 01.

- Rentals: Loss of Possabilities rent
- Investments: This is based on our Canoe Fund investment making a modest income (5%) as opposed to the 10% gain in 2019.

Forecast transfers from other funds:

- \$580 Transfer from Fund 10 Concert Series towards office expenditure and share of UCC (income) assessment.
- \$12551 Transfer from Fund 15 investment profits from 2019 as approved by the Board of Trustees.

The forecast expenses for 2020 are \$3,000 (~1%) – pretty much the same as last year:

• Payroll: The figure includes a payment in arrears from Dec 2019 (staff position transition from hourly to salary) and cost of living increases for all staff.

• Chinook Winds Assessment: This is based on 4.5% of our average gross income of the previous 3 years, (less contributions to M&S and other registered charities), plus a new additional fee for the new Chinook Winds Region, (total now 4.95%).

Once again, we are forecasting a deficit of \$24,700 for 2020.

Over previous years we have accumulated a surplus of over \$105,000 in Fund 1. Fortunately, these surplus funds are sufficient to cover the forecast deficit. There is also the possibility that if the investment in the Planned Giving Fund makes another good profit again in 2020, that 50% of this could again be directed to Fund 01 to cover the shortfall.

However, this is eighth consecutive year we have forecast a deficit; the surplus funds will not cover the continuing shortage of income indefinitely.
