Welcoming newcomers and collection of offering is an ongoing discussion. One concern about newcomer perception is that when offering is received many people do not place anything in the plate because they make their contribution by pre-paid cheque or through PAR.

Paige Martin suggested that while the offering plate circulates a slide mentioning that offering is gratefully accepted via PAR (Pre-Authorized Remittance). Janet Layton suggested that offerings can include more than a monetary donation: a prayer or hope can be written on a slip of paper and placed in the offering plate allowing people to actively participate in this portion of the service even though they are not placing a donation on the plate. Cards stating that "I make my donation through PAR" are available for people to place in the plate if they choose to do so.

Members are encouraged to wear their nametags as a welcoming initiative.

ACTION ITEM: Jope Langejans will format something to inform people of the various ways that contributions are collected each week. IE. PAR, pre-paid cheque, placing offering in the plate on Sunday. This will be displayed on the screen while offering is received.
